The Board extended the current Annual Plan until the end of June to fulfill their grant funding obligations that end in June.


The Board will be participating in an annual planning process starting in May 2024 for the 2024/2025 year.

Advocating together: Expedite the launch of the co-op housing development program Campaign

In April 2022, the Federal

government announced the Cooperative Housing Development Program – the first federal investment in co-op housing in 30 years. The co-op housing sector welcomed new investment after years of advocacy and have put forward expert advice during the co-design process.

Growth and Development

Expression of Interest – Firehall Acquisition

The Board approved the Firehall Development Steering Committee Terms of Reference and the Opportunities Steering Committee Terms of Reference. These Committees will report to the Board monthly.

The Board presented a draft Memorandum of Understanding (MOU) to the Town of Mahone Bay to formalize how they should work together to support the growth of Co-op homes in Mahone Bay.

Nova Scotia Community Housing Growth Fund

MBCLC secured two funding grants from the Nova Scotia Community Housing Growth Fund – administrated by the Community Housing Transformation Centre (CHTC).

The CHTC approved an extension for one of the grants to provide the Co-op with additional time to explore a development opportunity. Solterre Design has completed a feasibility study which includes costing to design twelve units.

CHF Canada has been engaged to support the Co-op with the second grant, that ends in June 2024. The project deliverables for this grant are tracked in the Annual Plan provided for the Board's review monthly.
